IMPORTANT INFORMATION

Parents/guardians of College of the Sequoias' students under the age of 18 are responsible for their children, including but not limited to, transporting them to class and retrieving them after class. Please be aware that periodically classes may end early, may be cancelled without prior notification, or may vary from the scheduled time or place.

Terms/Conditions:

1. High School students may register on or after their registration date and time.
2. Dual/Concurrent enrollment students must be at least 13 years old to take classes at COS.
3. A Banner ID (Student ID) is required in order for student to complete the registration process.
4. Each semester a new high school permission form is required for registration.
5. Students who miss two consecutive semesters (Fall & Spring) must reapply to the college.
6. Concurrently enrolled high school students are not allowed to take remedial classes – 300 or 400 level.
7. The district waives up to 11 units of enrollment and related fees per semester.
 - a. Material fees, Textbooks and classroom supplies (which may include computer software) are not waived.
 - b. Parking permits are not waived.
8. Physical education classes are limited to a maximum of 10% of high school per class section. If enrollment exceeds 10%, students will be dropped in reverse order of registration.
9. If the high school student is home schooled, the student and parent/guardian need a current private school affidavit. This is required per (CA Ed Code 33910)
10. High School students may be determined to be eligible for admission to COS college level courses if they have a 2.0 or higher high school grade point average.
11. Units earned at COS will be recorded on the COS transcript as college units. If students wish to petition their high school for high school credit for COS classes, students must request that their COS transcript be sent to their high school at the end of the semester.
12. COS is regulated by federal mandate to comply with the Family Educational Rights of Privacy Act (FERPA) and is not allowed to share non-directory information (grades, schedule, etc.) with the parents/guardians (even if the student is under 18 years of age) unless we have a signed consent by student.
13. As part of an on-line course or hybrid (partial on-line) course, students may be required to develop a cyber- identity. Students may also be required to develop an electronic portfolio to be utilized in an educational community networking environment. Parents/Guardians of minors should be aware that a K-12 environment which complies with the Child Internet Projection Act (CIPA) provides a greater level of protection than is provided in a college environment.
14. Please be aware that college course content and class environment may contain mature themes.
15. Education Code, Section 48800, 48800.5 and 76001 allow a limited number of eligible students to attend advanced courses at a community college.
